

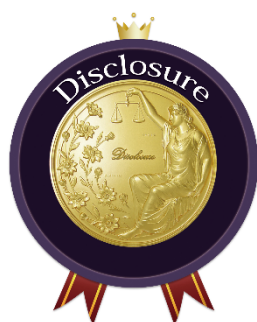

- ① Attitude of top managements toward IR activities, function of IR department, companies' fundamental approach to IR activities
- ② Information disclosure through announcement sessions, interview and informational materials
- ③ Fair disclosure
- ④ Information disclosure related to ESG
- ⑤ Voluntary information disclosure aligned with conditions in relevant sector
