## Mitsui Chemicals and Sinopec to Conclude a Joint-Venture for Bisphenol A in China

Mitsui Chemicals, Inc. (MCI) notifies MCI and China Petroleum & Chemical Corp. (Sinopec Corp.) have obtained a business license from the Chinese government to form a joint venture (JV), which will produce and sell bisphenol-A (BPA).

The both companies could further enhance each of competitive strengths in the business environment marked by ever-intensifying international competition. MCI which is the largest phenol and BPA manufacturer in Asia and Sinopec Corp. which has China's largest phenol (PHL) production capacity, cooperate in the field of BPA, which is a PHL derivative. The two companies have examined to establish the JV producing BPA on equal investment basis, since they signed a letter of intent in March 25, 2004. At this time, they obtain the business authorization from the Chinese government. Moreover, they agree the both firms continuously examine the expansion of cooperative ties.

The summaries of the new JV company and plant are as mentioned below:

The production process will be the latest ion-exchange

The parties have agreed on the BPA plant's receiving its requirements under internationally competitive pricing arrangement from the PHL plant of Shanghai Gao Qiao Company, a refining and chemical branch of Sinopec Corp., which launched the new plant's operation from

March 2005.
